SHOW CAUSE NOTICE U/S 17 OF NCTE ACT, 1993

126 MAR 2018

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 01.12.2014.

- 2. AND WHEREAS, recognition was granted by NRC to Lala Jagat Naryan Education College Muktsar Road, Tehsil-Jalalabad, Dist-Ferozpur (Punjab) for B.Ed. course vide order No. NRC/NCTE/F-7/PB-537/2008/48639-45 dated 09.05.2008 with an annual intake of 100 seats, thereby making a total intake of 200 students.
- AND WHEREAS, the institution, by affidavit consented to come under New Regulations, 2014.
- 4. **AND WHEREAS,** Revised Recognition Order dated **30.05.2015** and order dated 03.01.2018 was issued to the institution for conducting **B.Ed.** course programme of **two years** duration for four units from the academic session 2015-2016 subject to fulfillment of the following conditions:-
- (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds as per Regulations, 2014 and inform Regional Committees with required documents by May 30th, 2016.
- (ii) The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified Performa available on the website to the Regional Committee in proof of having provided additional facilities before May 30th, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- (iii) The institution should have already identified/selected the faculty/staff by 29th February, 2016 for which the approval from the affiliating body for the same be submitted to this office immediately.
- (iv) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition after May 30th, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- (v) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- 5. AND WHEREAS, the institution has not submitted documents/reply in compliance of the revised recognition order.

- 6. AND WHEREAS, the number of units were reduced from four to two vide order No. File No. NRC/NCTE/PB-236 & PB-537/277th Meeting/2017/186625-29 dated- 03.01.2018. on request of the institution.
- 7. AND WHEREAS, the matter was placed before the Northern Regional Committee in its 281st meeting held from 20th to 21st February, 2018. The Committee decided to issue show cause notice to all such institutions which have not submitted compliance of the revised recognition order.

AND, NOW, THEREFORE, this show cause notice is issued to the institution with a direction to submit representation within 21 days from the date of issue of this SCN before withdrawal of recognition u/s 17 of NCTE Act, 1993 for non-compliance of the above conditions. In case, the office does not receive any representation within stipulated time, it will be presumed that the institution does not wish to make any representation, and the Northern Regional Committee shall take decision as per provisions of the NCTE Act and Regulations.
