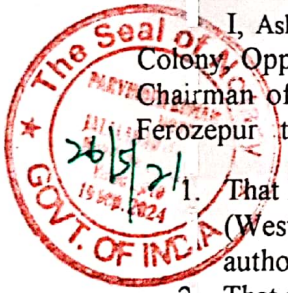

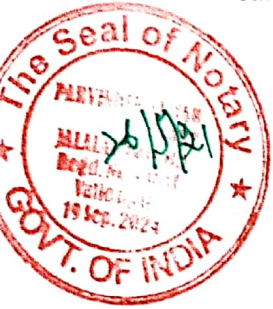

1. That I am Chairman of Lala Jagat Naryan Educational Society, Bahamni Bazar, Jalalabad (West), Distt. Ferozpur signing this Affidavit of behalf of it for which I am fully authorized.
2. That the managing society/ trust had made an application to the NRC, NCTE for running an institution, namely, Lala Jagat Naryan Education College, Vill. Chak Arian Wala, Shri. Muktsar Sahib Road, Jalalabad (West) for B.Ed with an intake of 100 (2 Units of 50 Seats) for M.Ed with an intake of 50 (1 Unit 50 Seats) for D.El.Ed with an intake of 50 (1 Unit 50 Seats)
3. That the managing society/trust of the institution has constituted the Selection Committee for appointment of faculty as per the policy of the State Government/University.
4. That the following faculty members have been appointed by the duly constituted selection committee having requisite qualifications and experience as prescribed in NCTE Regulations. Details of qualifications and experience are given in Annexure – I.
5. The staff has joined/shall join the duty in the institution and will not be permitted to serve in any other institution on regular basis without appointing eligible teacher/principal and the same will be intimated to the affiliating body and NRC-NCTE.
6. That the academic staff of the institution (including part-time staff) is/shall be paid salary in such scale of pay as prescribed in the UGC/University/affiliating body from time to time. The supporting staff shall be paid as per the UGC/State Government/Central Government pay scale structure.

7. That the society/trust has appointed required number of Technical support staff and Administrative Staff of the requisite qualifications and experience as per norms and standards laid down by NCTE/State Government/Affiliating body. Salary is being/shall be paid to the staff members through bank/account payee cheque as prescribed by the NCTE.
8. The management of the institution shall discharge all the statutory duties relating to pension, gratuity, provident fund, etc for its employees as per the admissibility. The institution shall follow the norms of the NCTE as amended from time to time.
9. The details of staff appointed shall be displayed on the official website of the institution i.e. [www.lineducollege.com](http://www.lineducollege.com) (website of the institution).
10. The information about staff has been verified from the original records submitted by the candidate and found correct.
