- Applicant shall deposit, licence fee, EDC and all other charges levied or to be levied by the Housing and Urban Development Department from time to time.
- Applicant shall develop the site after getting the Building Plans/Layout Plan approved from the Competent Authority.
- iii) The issue of ownership of land is independent and exclusive of permission of Change of Land Use. Therefore, this permission of CLU does not in any manner grant or effect ownership of right of this land, which have to be determined by Competent Authority. The Applicant in whose hand this Change of Land Use lies shall be bound by the decision of such Competent Authority.

- iv) Applicant shall be responsible for any litigation if any regarding land in any court of law.
- Through revenue rastas passing through the site shall be kept unobstructed.
- vi) Applicant shall obtain NOC from PPCB if required under the Water (Prevention and Control of Pollution) Act, 1970, Municipal Solid Waste Management and Handling Rules, 2000 or any other relevant Act before undertaking any development at site.
- vii) Applicant shall not make any construction under HT/L.T. electric lines passing through the site or shall get these lines shifted by applying to the concerned Authority.
- viii) This permission will not provide any immunity from any other Act/Rules/Regulations applicable to the land in question.
- ix) Applicant shall obtain NOC from the Forest Department if required before undertaking development at site.
- Applicant shall make provision of rain water harvesting within the project area at its own cost.
- xi) Applicant shall make its own suitable provision for drinking water supply and disposal of sewage & solid waste management and shall not obstruct the flow of storm water/ rain water of the surrondings areas.
- Applicant shall obtain any other permission required under any other Act at his level.
- xiii) The applicant shall get the building plans approved from the Competent Authority as per regulalrisation policy and undertaking submitted by him.
